5. **Approved: Budget for 2017/18 as attached:** Staff costs are as per the SLCC National Agreement, scale SCP18. The Burial Ground Trust is to receive £200. Agreed to support the Village Hall Trust with a contribution of £2500 towards the playing fields maintenance and insurance. The budget for the public conveniences was set at £4618.00, due to the necessity of keeping the toilets open for public health reasons, Powys County Council having stopped the grant to maintain the toilets. This sum accounts for the the increase in the precept over last year.

6. **Setting of Precept figure for 2017/18:** Resolved that the Precept required for 2018/19 be set at £14,558.
