Llangynidr Community Council had 10 councillors for most of the year, 1 councillor retired at the March meeting.

4 advisory committees: planning, HR, Finance and Rights of Way.

The Council has a positive and beneficial relationship with it's County Councillor.

No complaints were raised in this financial year.

Assets are the public conveniences, persondy field, the tump, the old ford, the path past the walnut tree stores, the riverpath and the car park, no change there.

Four Community enagaement exercises were undertaken: Annual parish meeting, 3* village conversations including the car parking review (with Powys County Council).

Long term conisderations are to maintain the benches and picnic tables, repair the toilets, maintain the trees on Council property, improve biodiversity and engage with the community.

The introduction of the 20mph limit has been sucessful for residents who walk around the village, it is less popular, generally speaking, with drivers.

Speedwatch volunteers have recorded many vehicles travelling over the speed limit.
