There is a review of High Schools at the moment with closures likely, although Crickhowell High School do not seem to be under threat. There is to be a 4% increase in Council Tax, in some areas it will be close to 5%.

Leisure Centres are to be reorganized and the Community Centre at Crickhowell will be run by the School.

- 8. Duffryn Road there are pot holes and the sides of the road are collapsing in places. Powys County Council have cleaned the road for which the Community Council is grateful. RH and GM went to inspect the area where the spring comes across the road, unfortunately the road is in a bad state of repair. There is a good deal that needs attention. RH will get the Brecon Manager to meet with Community Councillors and RH to see the damage. It should be noted that Glaisfer Road is also in a bad state of repair near High Meadow.
- 9. Traffic conditions in the village, particularly those between the village hall and the car park, and those around large local events. The Safety Advisory Group for the area, the Health and Safety Executive and AA signing are potentially involved in decision making for large event traffic safety. It was noted that it is not just large events, road traffic accidents on the A40 can cause problems.

The safety of the crossing of the road between the village hall and the car park was discussed. Mr Kane offered to put playground signs on the road near the village hall. Mr Kane was thanked for his contribution to the meeting.

- 10. Request from Llangynidr Primary School for a donation towards play ground equipment for the Infants. The School have managed to raise £4000 for the play equipment in the Infants' playground and are now looking to raise a similar amount for the Juniors' Playground. It was explained that the Community Council's budget had been set for the financial year. However, the School would be welcome to request funding next January and any such request would be considered sympathetically. Mrs Jenkins was thanked for her contribution to the meeting.
- 11. Commons Act 2006 Section 16 application: Deregistration and exchange of common land at Trefil- Las and Twyn Bryn-March common (BC15) in connection with the Circuit of Wales. An inquiry has now been arranged to consider the above Common Land application.
